McElvain Energy Inc. is seeking approval to extend the proposed well pad for the EK 30 BS2 Federal Com 1H. The well pad expansion is necessary to accommodate the drilling and completion of 2 additional horizontal 2nd Bone Spring oil wells (EK 30 BS2 Federal Com 2H & the EK 31 BS2 Federal Com 1H) on this pad. Both APDs have been submitted via hardcopy to Melissa Agee in the BLM CFO.

The extra space is necessary for the mobilization of the drilling and completion equipment, and the installation of the additional surface production equipment necessary to support production operations for a 3 well pad.

An Archaeological Survey will also be performed on the proposed extension area and a report will be submitted to the BLM when completed. I have attached the revised survey of the well pad with the

The original well pad was approved with the APD approval of the EK 30 BS2 Federal Com 1H well in 2015. The original well pad was 350' x 350'. We are requesting that the pad be extended to the southwest to allow for the drilling of the EK 30 BS2 Federal Com 2H, and the EK 31 BS2 Federal Com 1H wells. The west side of the pad extension measures 232.2', south side 340.6', and the east side 25'. These APDs are currently being processed in AFMSSII. Please see the attached plat with the proposed pad extension for greater detail.
