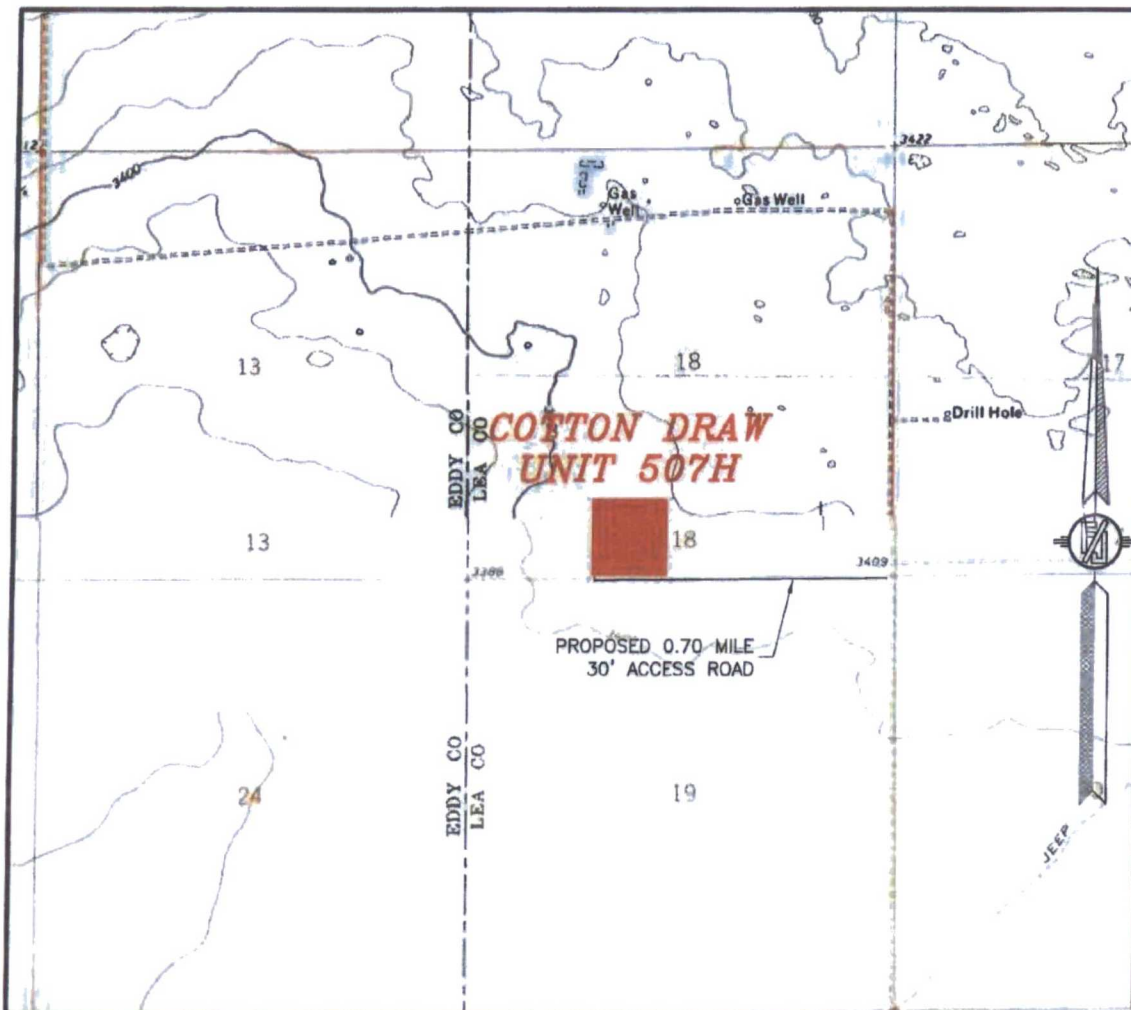

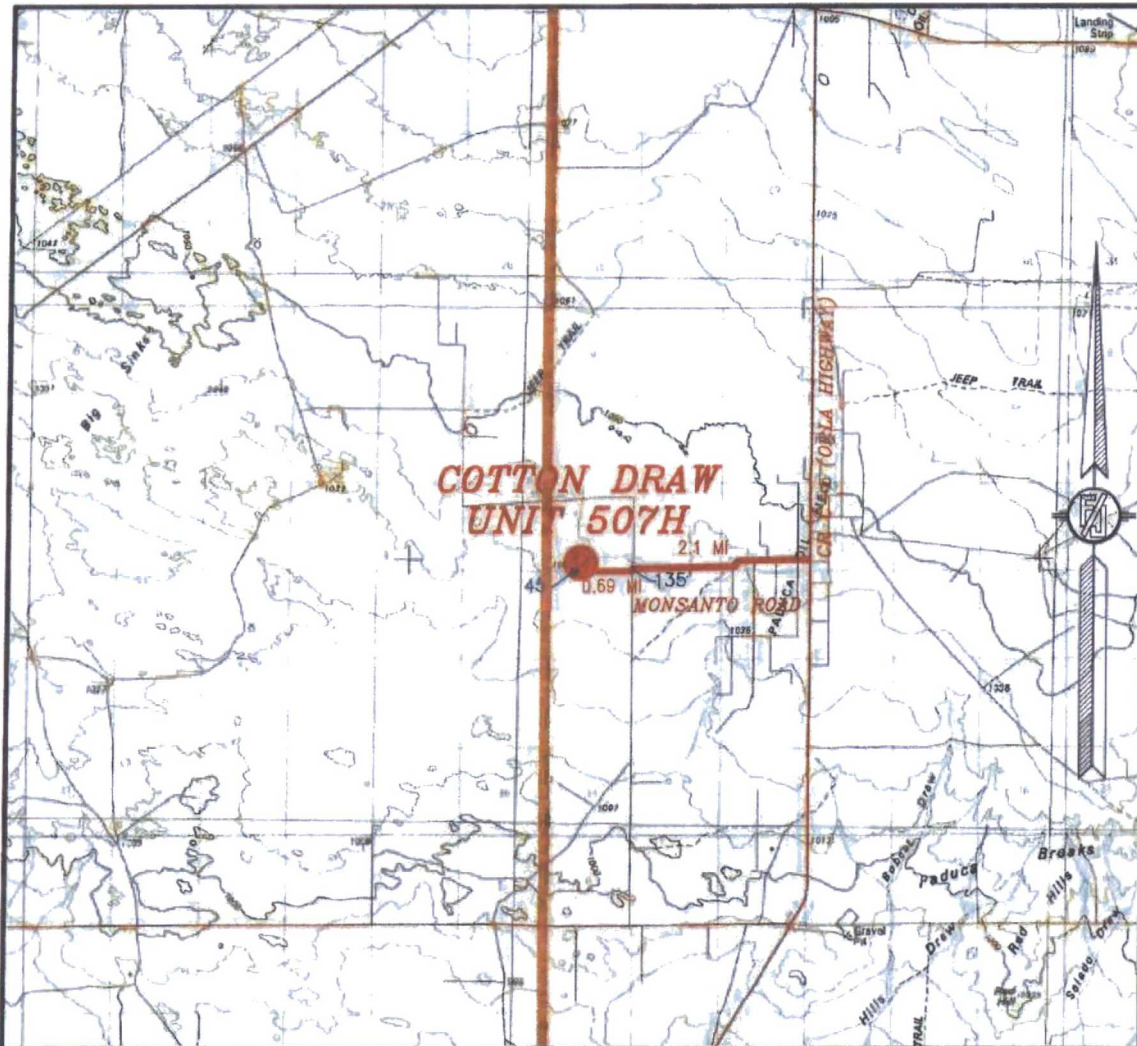

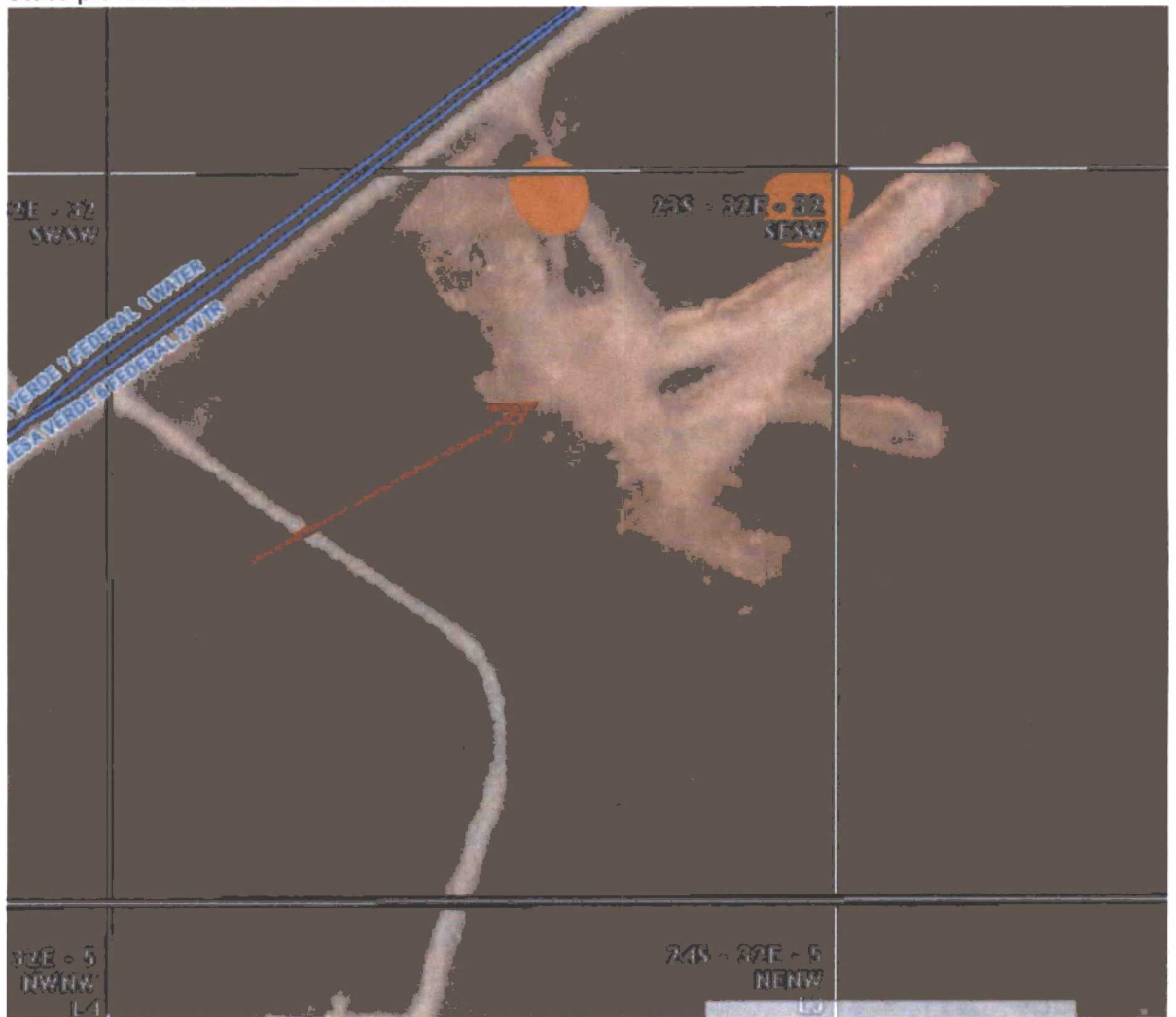


AERIAL MAP

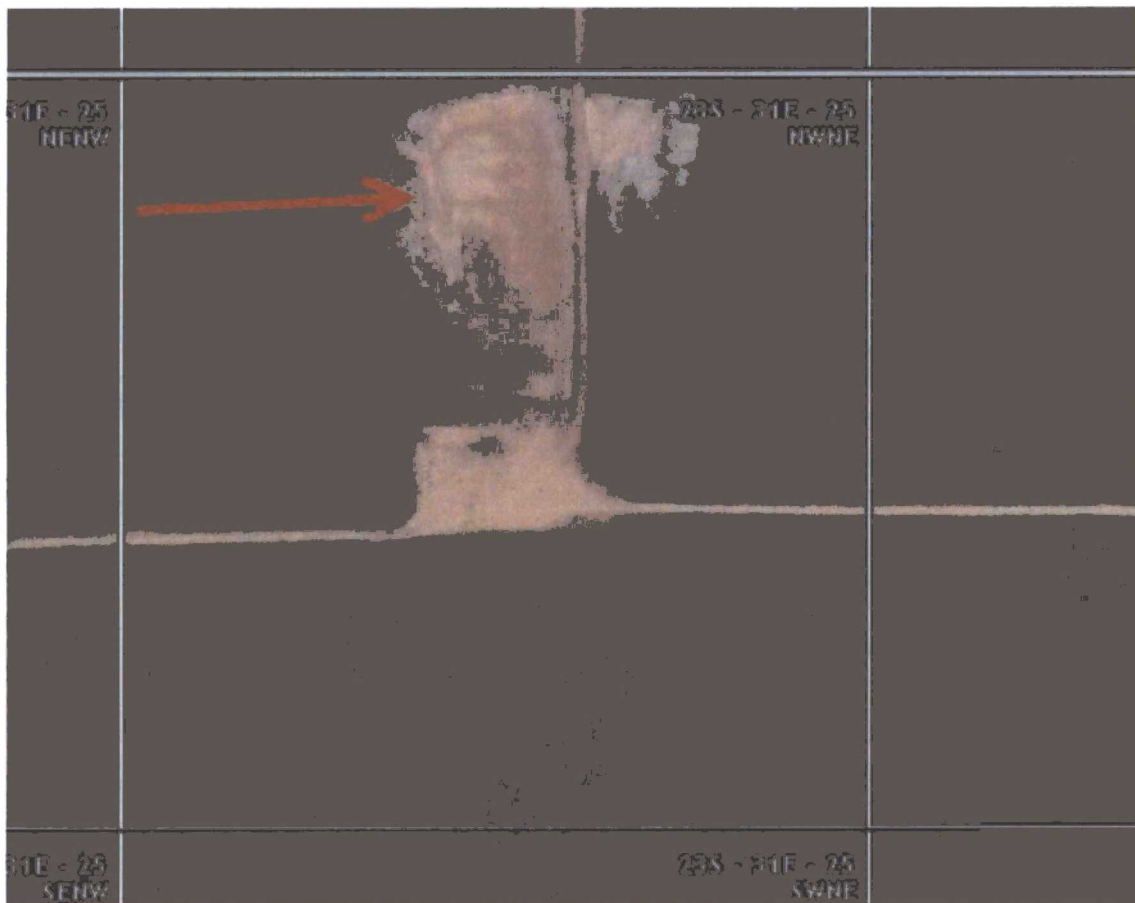
