7/25/17 2nd stage: Cement lead w/ 1200 sx Class C, 12.7 ppg, 2.37 CFS yield; tail w/ 75 sx Class C, 14.8 ppg, 1.45 CFS yield. WOC 8 hrs. Circulated 180 sx cement to surface. Resumed drilling 6-3/4" hole.
