10/12/17 - ND wellhead and NU BOP. POOH with production tubing. RIH and tagged junk in 5-1/2" casing at 4692'.
10/13/17 - Circulated 50 bbls brine and clean hole. Circulated hole and milled down to 4754'.
10/16/17 - RIH and tagged at 4975'. Broke circulation. Started milling and RIH with tubing to 8620'. Circulated hole clean.
10/17/17 - Spotted 25 sx Class "H" cement from 8620'-8397' calc TOC. Spotted 55 sx Class "H" cement from 5500'-5054' calc TOC. Set a 5-1/2" CIBP at 4460' and tagged. Circulated 70 bbls plugging mud. Pressure tested casing to 500 psi, held good.
10/18/17 - Spotted 25 sx Class "C" cement from 4460'-4207' calc TOC. Perforated at 3920'. Attempted rate (unable). Dropped down to 3970'.
Spotted 25 sx Class "C" cement from 3970'-3717' calc TOC. WOC to tag. Tagged TOC 3763'. Perforated at 2080'. Attempted rate (unable).
Dropped down to 2130'. Spotted 25 sx Class "C" cement from 2130-1877' calc TOC.
10/19/17 - Tagged TOC 1733'. Perforated at 485'. Established rate down 5-1/2" casing up 8-5/8" casing. Full returns to surface. ND BOP.
Pumped 120 sx Class "C" cement down 5-1/2" casing and up 8-5/8" casing from 485' up to surface. Topped off with cement.
10/24/17 - Cut off wellhead. Installed dry hole marker and cut off anchors. WELL IS PLUGGED AND ABANDONED.
