2nd stage: Cement w/ 1295 sx Class C, 12.7 ppg, 2.37 CFS yield; tail w/ 75 sx Class C, 14.8 ppg, 1.45 CFS yield. Circulated 260 bbls cement to surface. WOC 4 hrs.

10/8/17 Tested casing to 2600 psi for 30 minutes. Test good. Resumed drilling 6-3/4" hole.
