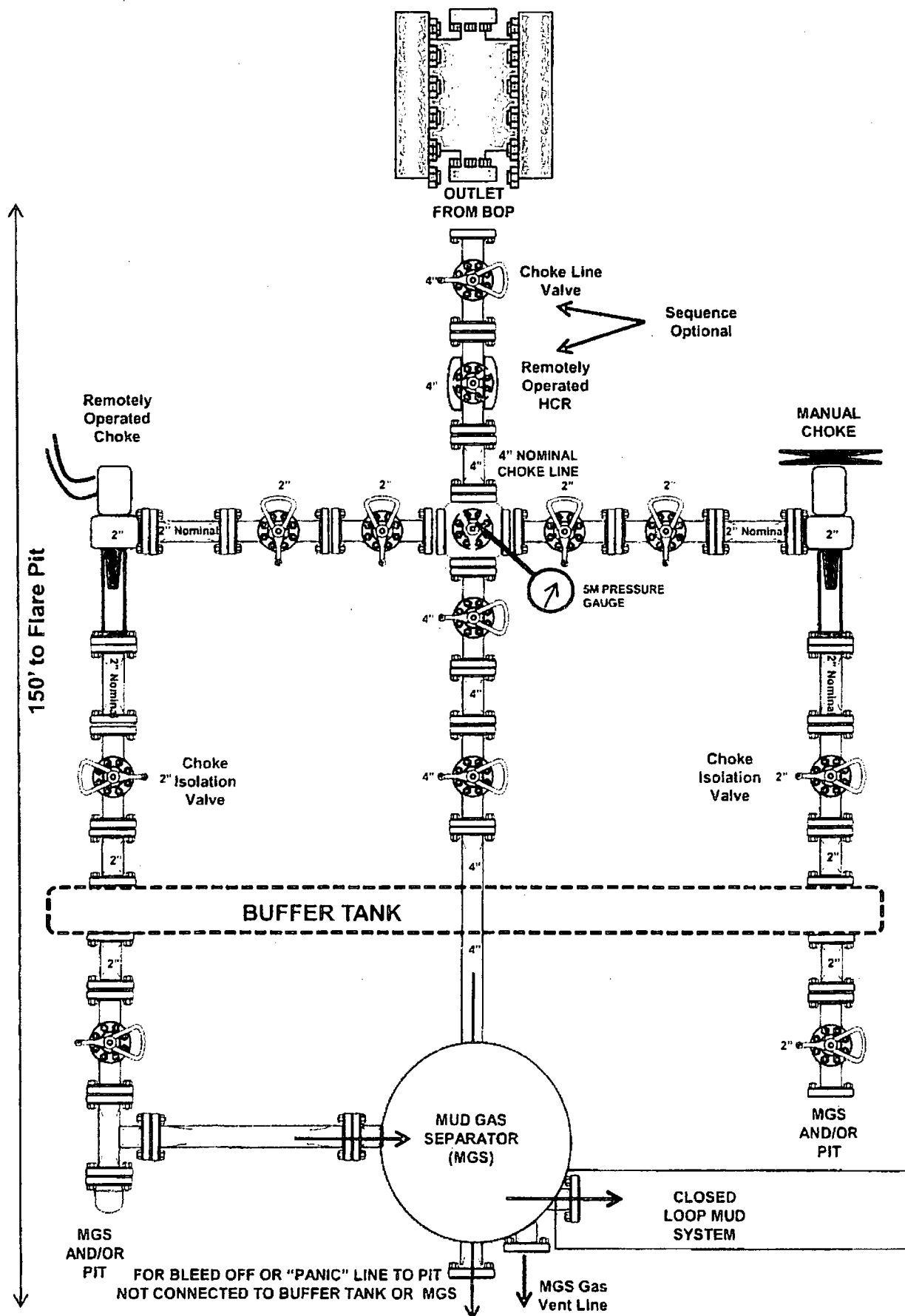

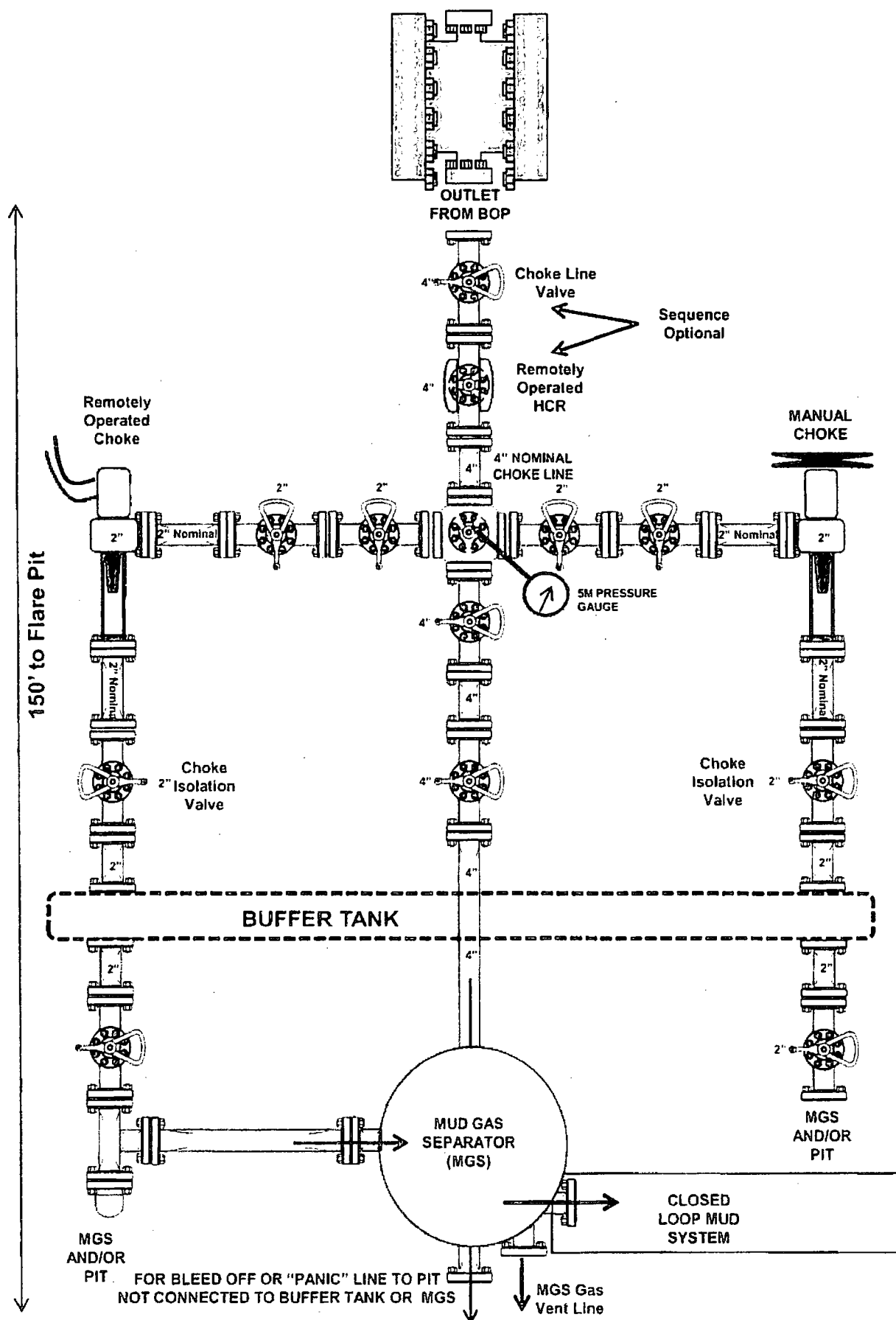

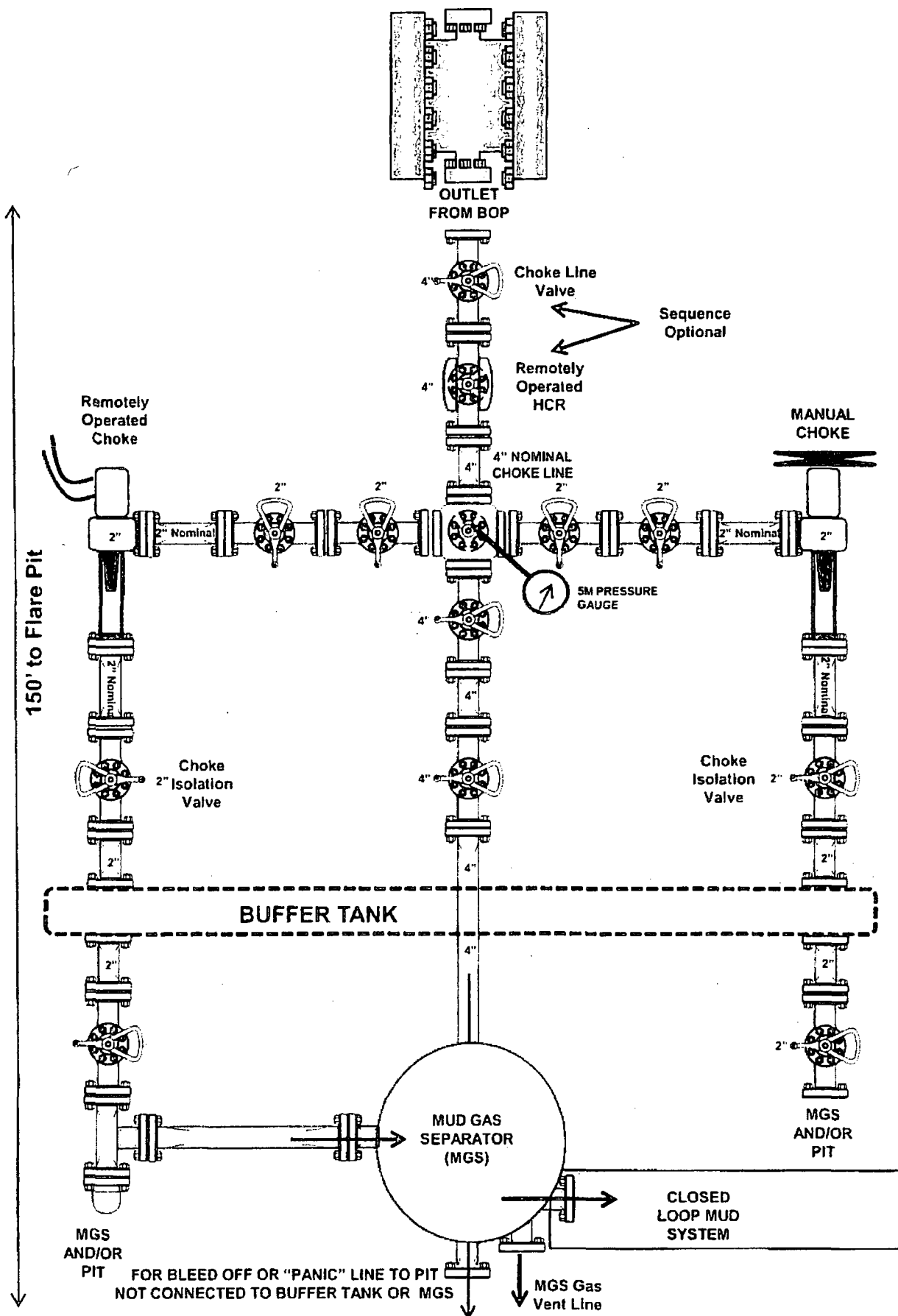
# 3M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)



# 5M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)

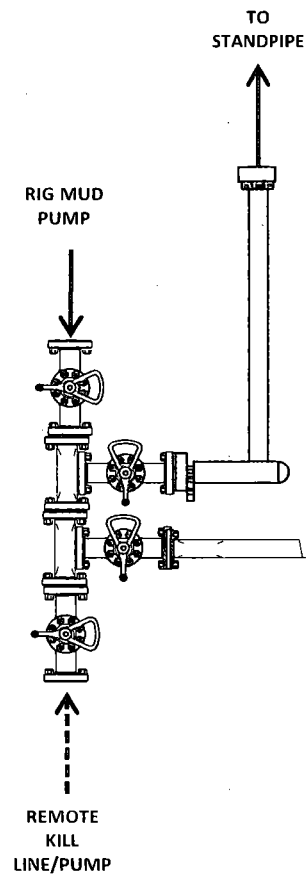


# 5M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)

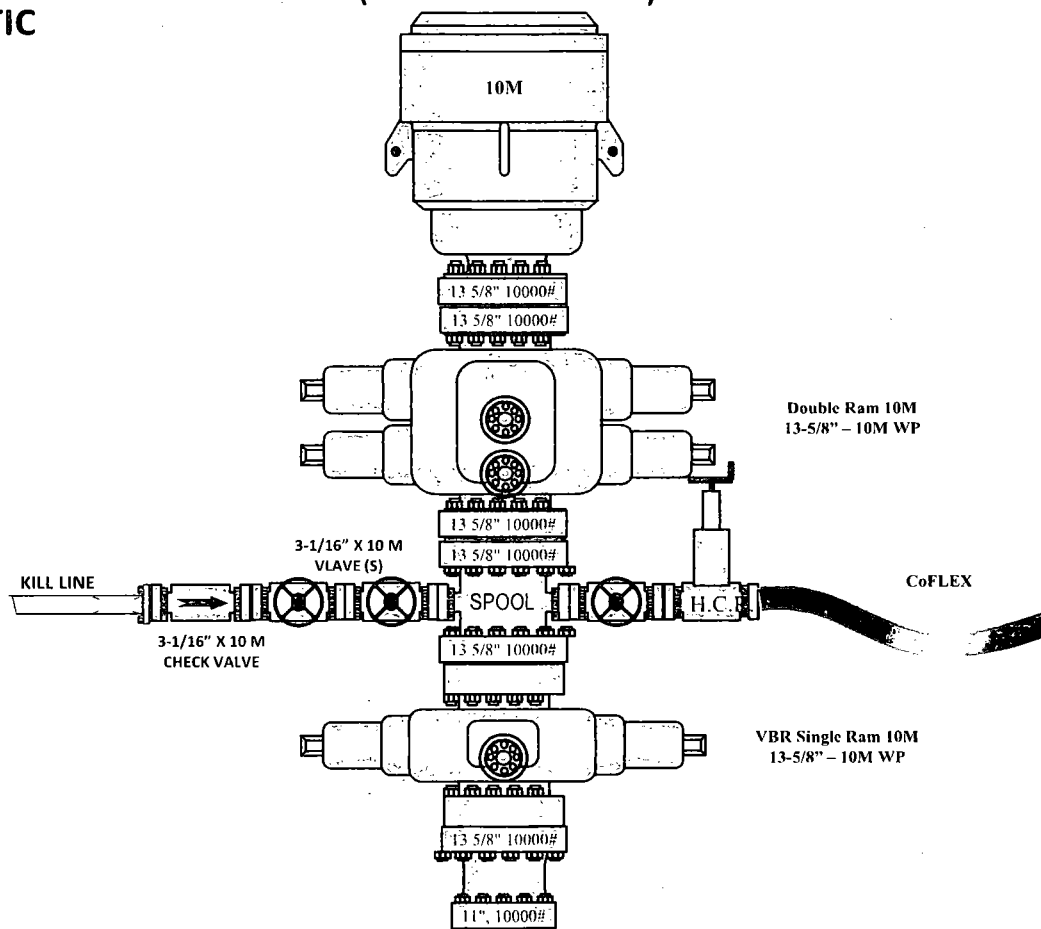


## 10M BOP Stack

### 10M REMOTE KILL SCHEMATIC

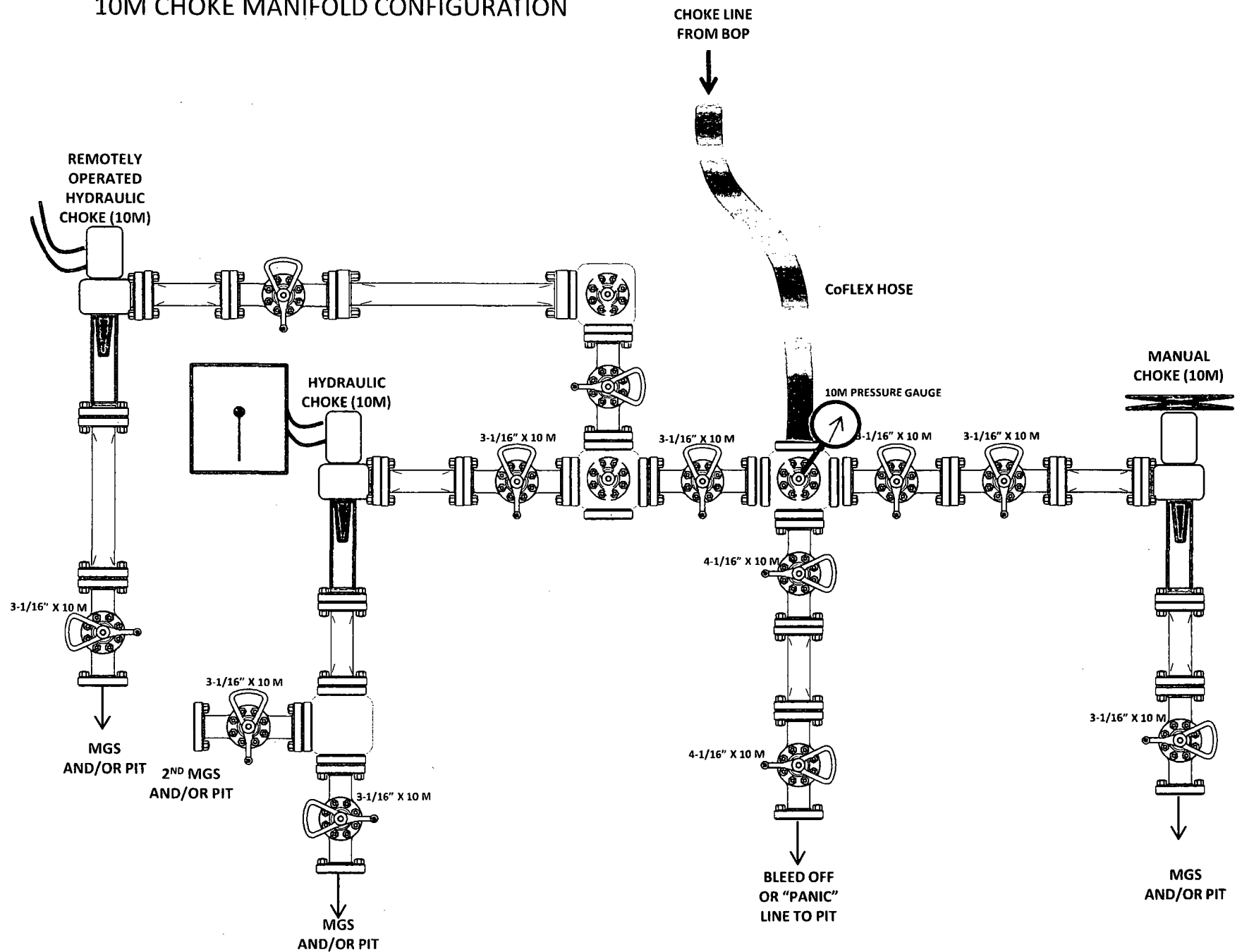


## 10M BOP Stack (10M Annular)

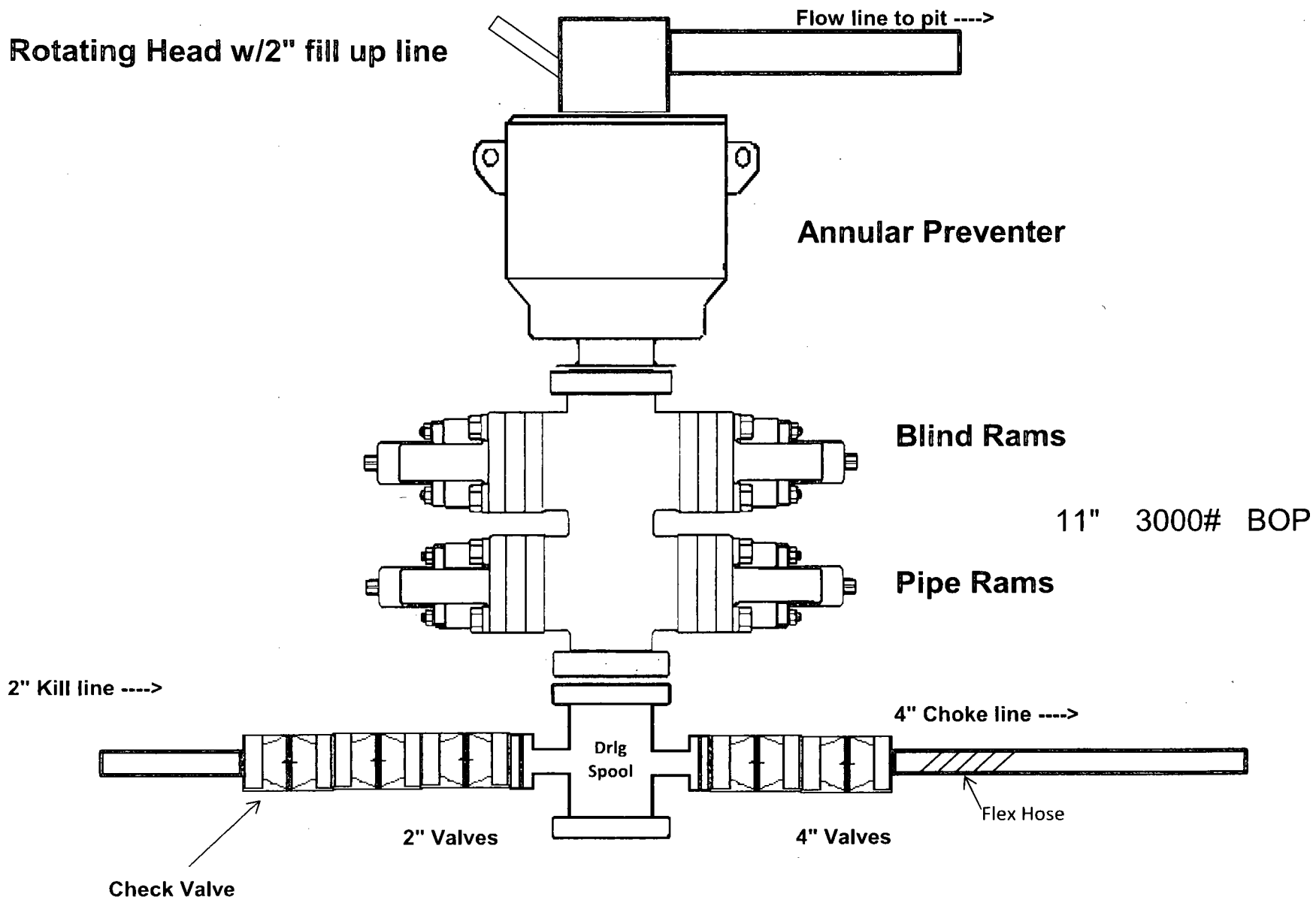




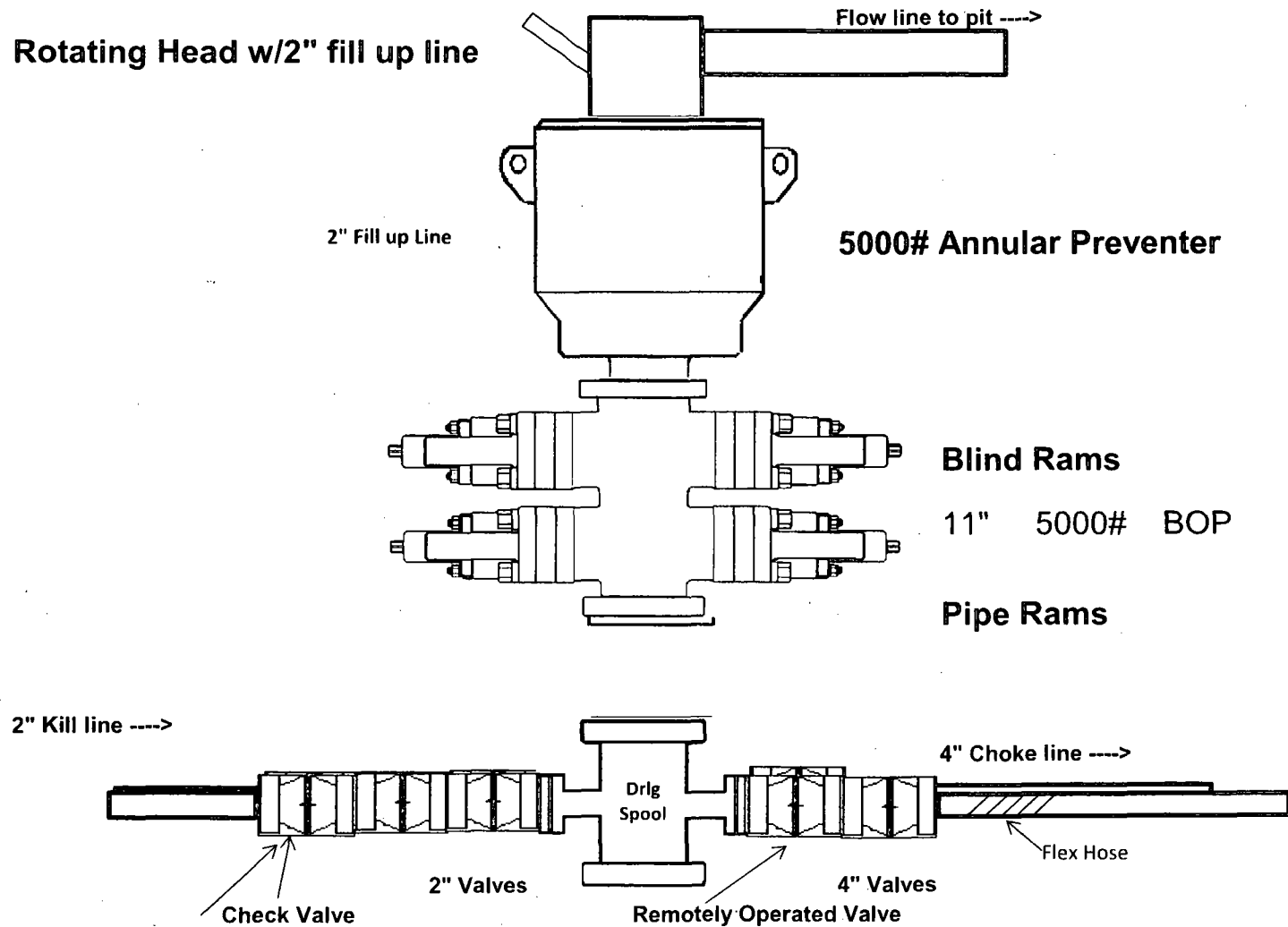
# 10M CHOKE MANIFOLD CONFIGURATION



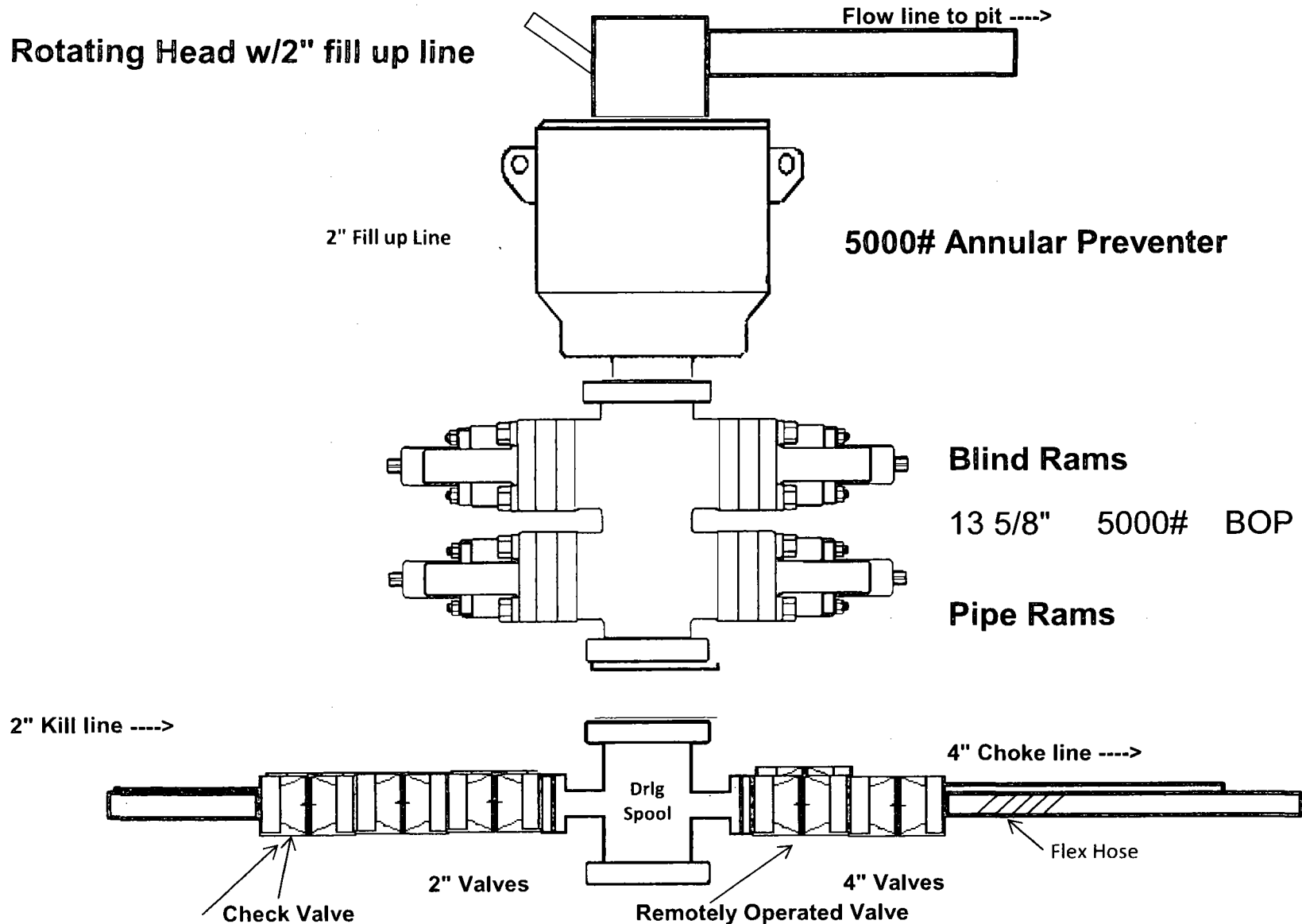
# 3,000 psi BOP Schematic

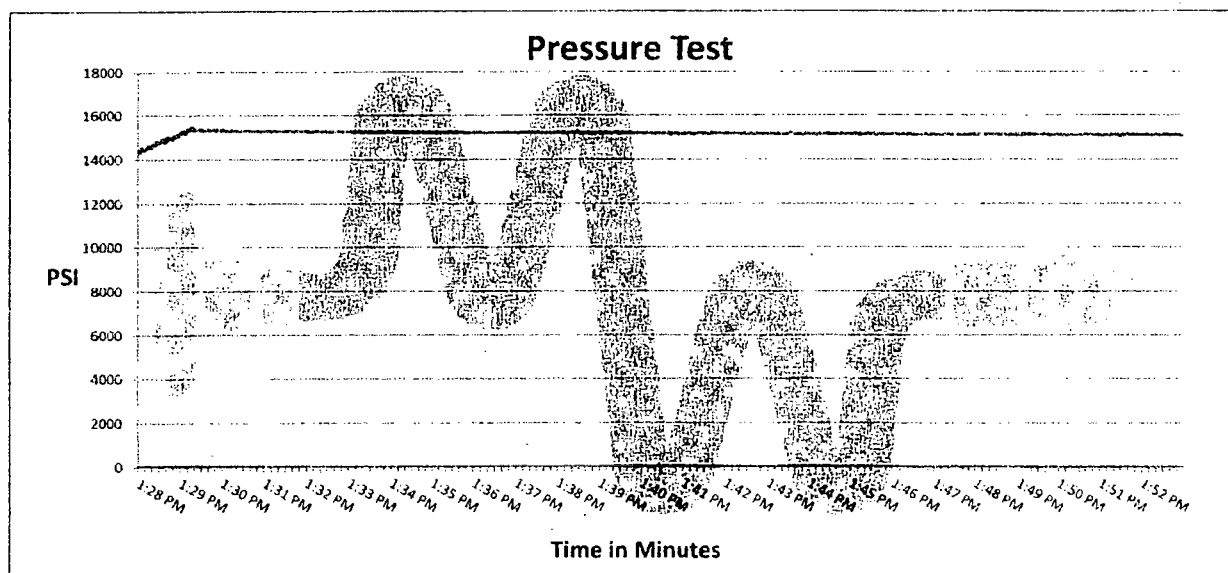

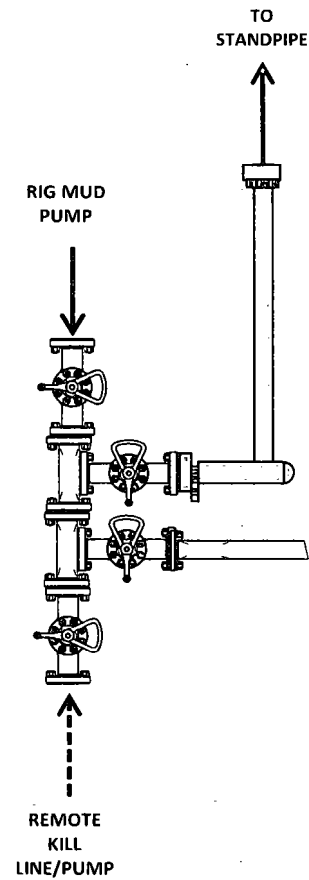

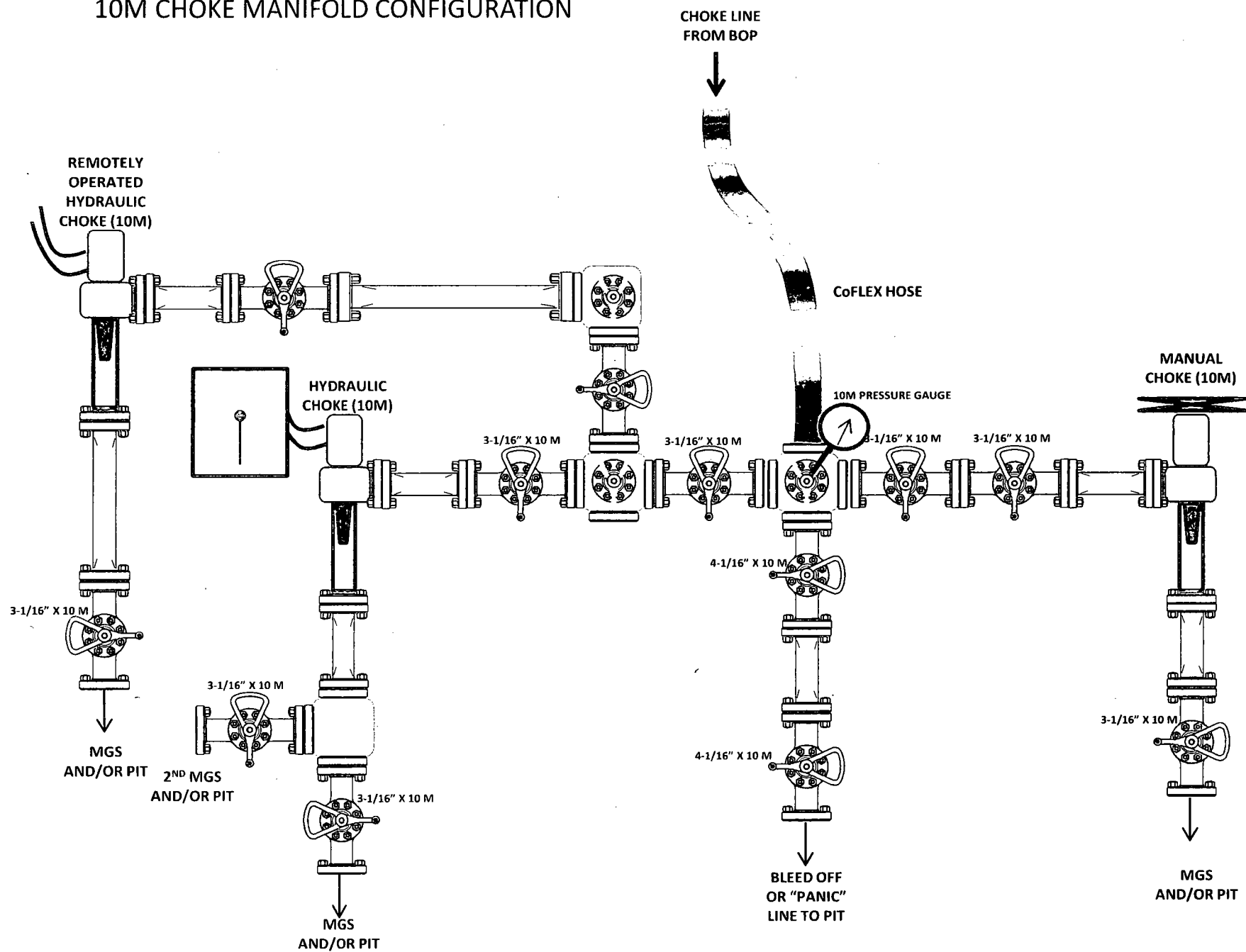
