



5M Choke Manifold Equipment (WITH MGS + CLOSED LOOP)











3,000 psi BOP Schematic




5,000 psi BOP Schematic

2. Well Control and Shut-In Procedures

Well control procedures are specific to the rig equipment and the operation at the time the kick occurs. Below are minimum tasks prescribed to assure a proper shut-in while drilling, tripping, running casing, pipe out of the hole (open hole), and moving the BHA through the BOPs. 


