05/15/2018 Mewbourne Oil is requesting permission to install a surface 2-7/8" steel flow line approx. 260' in length from the Jennings 27 W1AP Fed Com #4H to an existing battery on the Jennings 27 W0AP Fed Com #3H. With this change, a battery will no longer be required on the Jennings 27 W1AP Fed Com #4H pad. The average pressure of the surface flow line will be less than 125 psi. The flow line will follow Mewbourne's existing road disturbance.
