COG Operating LLC respectfully requests to add a surface 3" poly line along the existing lease road. The working psi will be below 125psi. The line will be a total length of 3060' and used to transport produced gas beginning at the BC Federal #35 well, tying in the BC Federal #9 well and the BC Federal #39 well then ending at the BC Federal #21 well where it will tie into the COG Main gas gathering system as shown on the attached map.

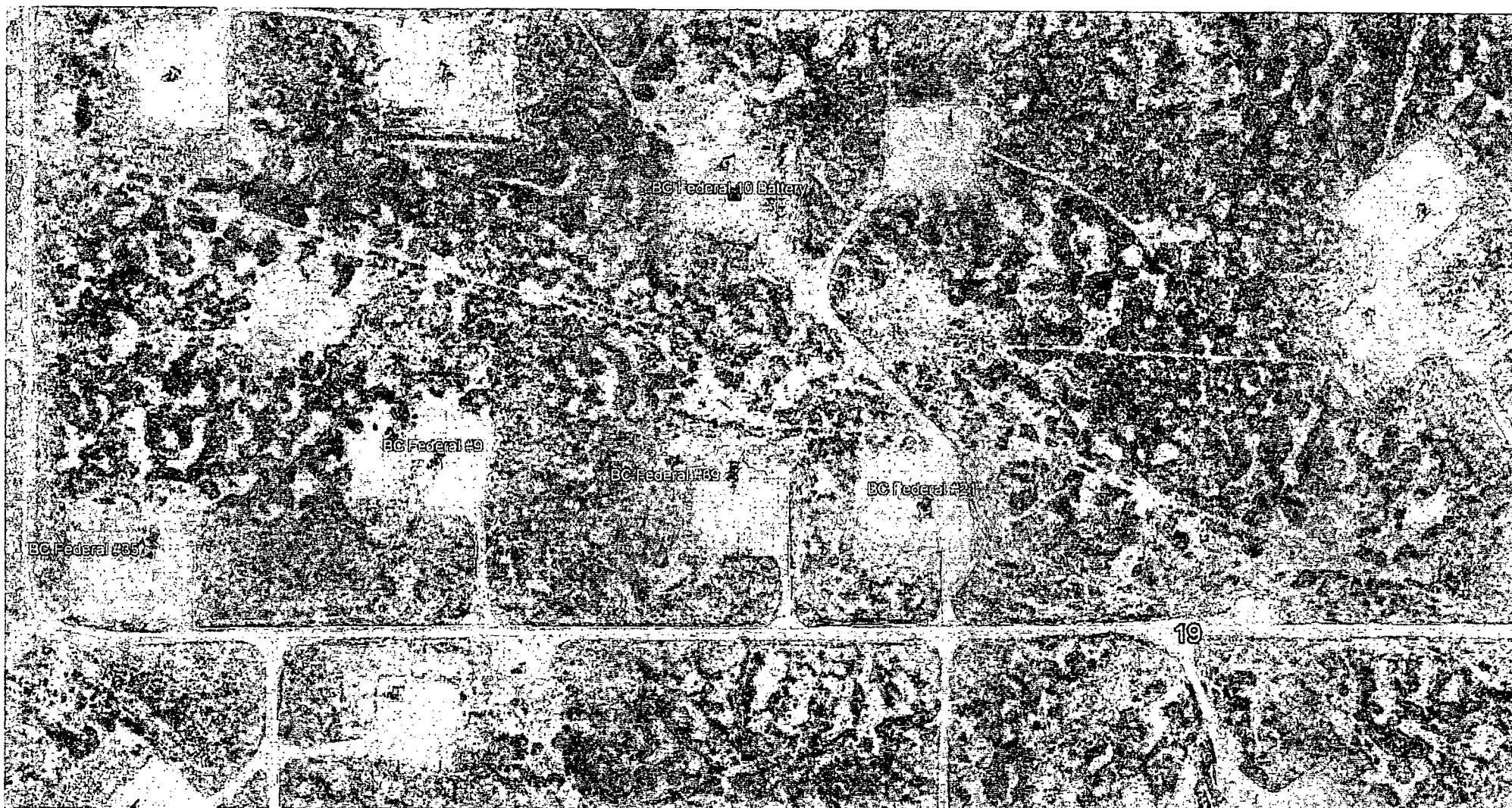
