If drilling operations have commenced on a well send all necessary reports (spud, casing/cementing, etc., 1 original and 3 copies) to the BLM so we may correct our records.

If you wish to drill this well at a later date, please submit a complete application (In AFMSS II data base) to this office. Since the original APD have expired, the resubmitted APD will be subject to all processing requirements including the \$9,790 application fee and the 30-day posting period. Please note on the resubmitted APD that they were previously approved and we will review the expired file for information which will help expedite the processing.
