POOH. Circulated hole with 150 bbls of packer fluid. RIH with tubing, packer and gas lift valves.

Set packer at 10167' and tubing at 10172'. Nipped down BOP and nipped up wellhead. Rigged down pulling unit. Released well to production. Well is now on gas lift.
