01/01/2020 - Drilled 12.25" hole to 4874'. Drill string became stuck. Multiple fishing and wash over attempts made to retrieve fish but were unsuccessful.
The top of fish is at 4368'. The base of salt is at 3860'. Cemented with 14.8ppg Class C from 4368' to 3760'.
The 13.375" casing shoe is at 1141'. Set a whipstock top at 1070' and bottom at 1103'. Anchor point is at 1107'. Milled window and 8' of new hole.
