### BOP Break Testing Variance (Note: For 5M BOP or less)

- While in transfer between wells, the BOPE shall be secured by the hydraulic carrier or cradle.
- Any well control event while drilling require notification to the BLM Petroleum Engineer prior to the commencement of any BOP Break Testing operations.
- A full BOP test is required prior to drilling the first deep intermediate hole section. If any subsequent hole interval is deeper than the first, a full BOP test will be required.

**BATCH DRILLING SEQUENCE OF THE 3H, 4H:**

- SPUD Maxus 8026 #3H – rig up walked out, drill 17-1/2" hole and set 13-3/8" csg
- Walk to Maxus 8026 #4H, SPUD 17-1/2" hole and set 13-3/8" csg, test BOP, drill 12-1/4" hole and set 9-5/8" csg.
- Walk to Maxus 8026 #3H, test BOP break, drill 12-1/4" hole and set 9-5/8" csg, drill 8-3/4" hole and set 5-1/2" csg
- Walk to Maxus 8026 #4H, test BOP break, drill 8-3/4" hole and set 5-1/2" csg
- Rig released
