The Weir #13 was recompleted to the Grayburg and brought into NMGSAU in December of 2019. While waiting on the results to determine economic success, approval to re-complete the Weir #11 to the Grayburg and bring the well into NMGSAU was received. Furthermore, we began the process of getting ROW approval from the BLM to bury the permanent flow lines.

Approval to lay the flow lines was given from the BLM on March 3rd, 2020. Due to the drop in commodity price in the following (2) weeks, Apache made the decision to postpone these projects due to economics. Apache still plans to bring these wells into NMGSAU in the future.

In an effort to stay in compliance, we are requesting a 12-month TA extension.
