- Isolate and acidize Blinebry fr/ 5844' - 5994'.
- RIH w/ IPC injection tubing & packer to 5750'.
- Notify BLM office prior to pressure testing casing per BLM regulations.
- Set up surface equipment.
- Begin injection in the Blinebry/Drinkard.
