FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

TD: 10,708-Lime

335' 13 3/8" casing set at 352' with 375 sacks cement, Cement circulated.
3874' 8 5/8" casing set at 3890' with 2300 sacks cement.
10189 5 1/2" casing set at 10200 with 400 sacks cement.

This well has been drilled to a total depth of 10,708 without encountering Oil or Gas in Commercial quantities. We therefore desire to abandon salvage and plug well in the following manner.

Using heavy mud between plugs, spot the following cement plugs 45 sacks 5290-5140; 30 sacks 3940'-3840'; (Cut off 8 5/8" casing at 400' and pull same) 25 sacks from 50' down in none recoverable 8 5/8" casing; 30 sacks from 377'-327' ; 15 sacks in top of 13 3/8" casing.
