Ran 4646' of 8 5/8" 32# Seamless H-40 & J-55 casing and set at 4660'. Cemented with 2500 sacks of Pozmix and 200 sacks of Neat. Circulated 400 sacks. Tested pipe and casing seat with 800 psi for 30 minutes before and after the drilling out of the cement on June 4, 1955 and both held O.K.
