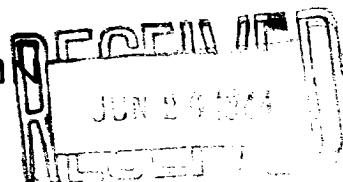

On January 28, 1944 we run 1280' of 8" surface casing, setting same above the salt in the anhydrite cementing with 50 sacks of cement. The plug was drilled on March 16, 1944 bailing the hole and testing for the water shut-off which was found to be satisfactory.
