We propose to PB and perforate additional Abo zones, acidize and recomplate in the following manner:

- 1. Pull rods and tubing.**
- 2. Perforate W/I--3/3" hole each @ 8617, 8619, 8621, 8635, 8645, 8653, 8661, 8663, 8670, 8677, 8684, 8689, 8693, 8696 & 8698.**
- 3. Run and set a retrievable BP @ 8710 with a RTTS tool above new perforations. (old perfs are from 8734--8764).**
- 4. Swab test and acidize new perfs (8617--8698).**
- 5. Pull retrievable BP set @ 8710.**
- 6. Swab test from all perfs (8617--8764.)**
- 7. Run rods and put back on pump.**
