DETAILS OF WORK

Will set 300' of 11 3/4" O. D. Spiral Weld casing and circulate cement. If commercial production is obtained, we will run 4 1/2" O. D. casing to an approximate total depth of 4800' and use sufficient cement to bring the top of the cement above the salt section. This well will be located 357' north 22 1/2° East of our Denius-Federal #3 which produces from the Abo Reef.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

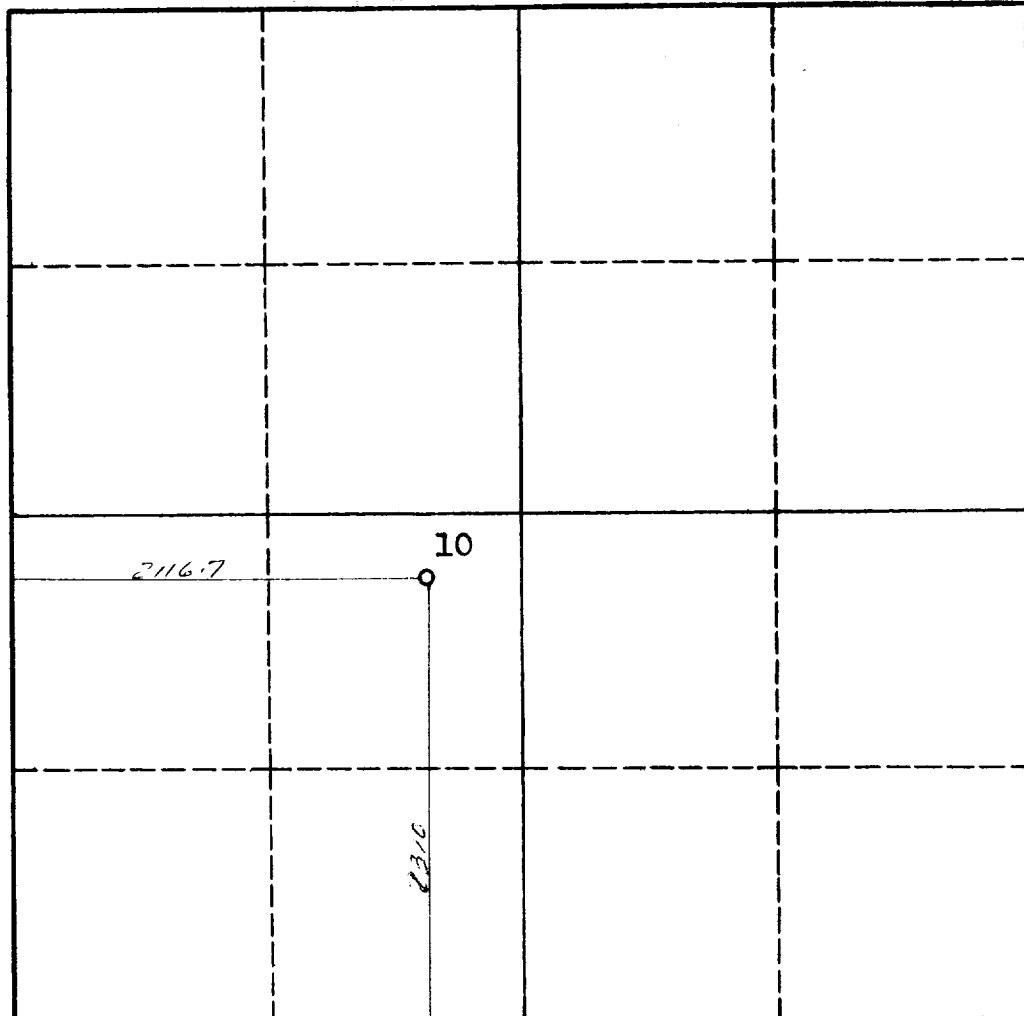

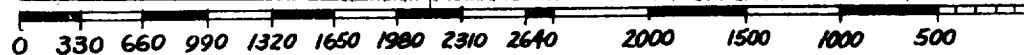
