Cut off 7" casing approximately 2200' down.  
Place 100' cement plug in and out of stub or at the base of the salt section.  
Cut and pull 8-5/8" casing.  
Place 100' cement plug in and out of shoe on 8-5/8" casing @ 1450'.  
Place 100' cement plug @ 300'.  
Place 10' cement plug @ surface.  
Install a 4" dry hole marker at the surface.
