O.T.D. 8855' Dolomite, PBTD 4868'. Workover complete. The Queen Formation was squeezed off and the Grayburg Formation was perforated and completed in the following manner. MIRU a completion unit and POOH w/BHP, rods and tubing. RIH w/5-1/2" cement retainer on 2-7/8" tubing and set cement retainer @ 3956'. Squeezed thru Queen Perfs @ 4004 - 4043' w/200 sacks of Class C w/2% CaCl₂ cement. POO retainer and reversed out 44 sacks of cement, left 7 sacks of cement in the casing and got 149 sacks of cement in the formation. POOH w/tubing. RIH w/RB on 2-7/8" tubing and DO to 4868'. POOH w/RB and tubing. Perforated the Grayburg Formation w/2 SPF @ 4616, 17, 18, 19, 20, 21, 22, 23, 70, 71, 72, 73, 74, and 4675'. Total of 28 holes (0.43" dia & 15.70" pen in Berea Sand). RIH w/5-1/2" packer on 2-7/8" tubing and set the packer @ 4519'. Acidized thru Grayburg Perfs @ 4616 - 4675' w/2500 gals of 15% NeFe HCl acid. Max press 2040#, min press 1850#, ATP 1950#, AIR 4.0 BPM, ISIP 1600#, 5 min SIP 1350#, 10 min SIP 1210#, 15 min SIP 1110#. 46 hr. SITP 0#. Swabbed -0- BO + 27 BLW/1 hr. and swabbed dry. Fraced thru Grayburg Perfs @ 4616 - 4675' w/21,000 gals crosslinked 40# gelled 2% KCL water + 52,100# 20/40 sand. Max press 3800#, min press 2980#, ATP 3200#, AIR 15.0 BPM, ISIP 1680#, 5 min SIP 1600#, 10 min SIP 1580#, 15 min SIP 1580#. 17 hr. SITP 60#. Swabbed 12 BO + 50 BLW/10 hrs. POOH w/packer and tubing. RIH w/2-3/8" tubing and set the tubing @ 4671'. RIH w/BHP and rods and put the well on the pump. Pumped on NMOC potential 19 BO + 15 BW/24 hrs., Grav. 35.1°, Gas @ rate of 14 MCFD, GOR 737.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either as shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
