

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On August 14 we ran 4311' of 7" 23# and 20# seamless casing. We cemented with 20 sax preceded by 10 sax of aquagel. The hole had filled up approximately 3000' with water. We thought 20 sax of cement would shut this water off and if production is obtained, we will go in and perforate the pipe and cement with an additional 100 sax. The water was swabbed out after allowing the cement to set 72 hours. Drilling ahead was resumed August 19, 1953 with the water shut off.
