A schematic diagram is attached which shows the current condition of this well. We propose to plug and abandon this well, as follows:

Pull tubing and packer.

Place CIBP @ 4965' in 7" csg. and place cement plug 4930' to 4965'.  
Perforate below 4965'.

Perforate 4 holes @ 704' and squeeze with 35 sx's. Class "C" cement.  
Place cement plug 604' - 704' in all.

Place cement plug 604' to 704' in 7" csg.

Place marker in 10 sxs. 2 surface.
