DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On July 7, 1949, at 12:01 a.m., 48 hours had elapsed since running 3151' of 5½" casing set at 3160', and cemented with 700 sacks to be used as oil string. At this time pipe and water shut off was tested by applying 1000 psi pressure and holding for 30 minutes before and after drilling cement plug. Pressure did not drop in excess of 100 psi. Drilling was resumed.

Temperature survey was not taken since cement was circulated to surface.
