Gentlemen:

Reference is made to your Notice of Intention to Drill Shell Wells Federal "TA" well No. 1, in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ sec. 22, T. 20 S., R. 33 E., N.M.P.M., Lea County, New Mexico, (copy attached), on Federal lease New Mexico 01130-C. This location is in the potash area designated by order dated October 16, 1951, of the Secretary of Interior.

Pursuant to the authority delegated by the Director of Geological Survey on January 20, 1960, I hereby approve the Notice of Intention to Drill the above described well to a depth of approximately 3,480 feet to test the Yates-Seven Rivers formation, undifferentiated, with the following stipulations:

1. That the surface pipe (8 5/8") be set at the top of the salt zone at an approximate depth of 1,500 feet, and the pipe be cemented to the surface.
2. That the District Engineer, U. S. Geological Survey, Box 187, Artesia, New Mexico, be notified in sufficient time to be able to recommend the setting depth of the production string and method of cementing.
3. That the District Engineer, U. S. Geological Survey, be notified in sufficient time to have a representative on location to witness all cementing operations.
