**DETAILS OF WORK**

Plugged and abandoned well December 23, 1961 at total depth 3440 feet. Top of anhydrite - 1467', top of salt - 1695', base of salt - 3038', top of Tansill - 3125'. The following plugs were placed:

1. 10 sacks at surface.
2. 20 sacks at 275' - 322'.
3. 20 sacks at 1450' - 1800'.
4. 30 sacks at 1680' - 1775'.
5. 30 sacks at 3000' - 3125'.
6. 20 sacks at bottom of hole.
