Acidized w/1500 gals. 15% NEFE HCl. Swabbed 13 hours and recovered 54 BO and 64 BW. Set RBP at 9700'. Perf'd Bone Spring (Zone "R" at 9572'-9609') w/2 SPF. Acidized w/3500 gals. 15% NEFE HCl. Swabbed and flowed 83 BO and 82 BW in 20.5 hours. Set RBP at 9552'. Perf'd Bone Spring (Zone "P" Dolomite) at 9478'-9502' w/2 SPF. Acidized w/2500 gals. 15% NEFE HCl. Swabbed 27 BO & 88 BW in 21 hours. Retrieved RBP's at 9552'-9700'. RIH w/2-7/8" production string to 10,159'. RIH w/rods and pump. Placed well on production.

6/16/88 - Well pumped 237 BO, 43 BW and 268 MCF in 24 hours.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
