NOTICE OF INTENTION

On January 6, 1959, a total depth of 3712' was reached. At this depth the tubing was set and the casing was cemented. A section of casing was penetrated. Oil immediately flowed to the surface and found to be of good quality. Casing was then tested for 2 hours with casing head. A heavy grade was obtained in this test. 2" NPT 4.75' tubing was run in hole, and preparations are now being made to install pumpjack and oil storage. Drilling is now completed.
