FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

I We propose to re-enter this well, drill out the cement plugs to a depth of 3500 feet, condition the hole with mud, log the salt section with an electrical survey, and re-plug the well.

II We plan to re-plug this well in the following manner:

- 10 sack plug of cement at 1900 feet to 1860 feet
- 10 sack cement plug at 250 feet to 210 feet at base of 8-5/8" casing
- 10 sack cement plug at top of 8-5/8" casing
- Regulation marker cemented at surface

Note: No testing for oil is involved in this operation.
