PROPOSED OPERATION

1. Pull rods, pump & tubing.
2. Run one-50 grains/foot string shot followed by one-100 grains/foot string shot from 3940' - 4046'.
3. Run tubing. Treat w/an appropriate chemical based on analysis of any scale found on the tubing. If there is no scale to analyze, treat w/1500 gallons 15% NE acid.
4. Swab load.
5. Place on production.
