Additional information:

This well was drilled to the total depth of 4000' and 2 $\frac{1}{2}$ " upset tubing run to 3985'. The well was then swabbed in and no gauge was taken. The well was then acidized with 2000 gallons of Dowell XI acid. The acid went in under Maximum of 1900# pressure and Minimum of 400#. Acid was allowed to set 6 hours and then the well was swabbed in and flowed for a short time and died. Then High pressure Gas was tied into the casing and the well kicked off with gas and as soon as it started flowing the High pressure Gas was immediately turned out of the casing. The well flowed for 15 hours and made a total production of 158 barrels of clean oil. Gas volume of 124,000.
