7" 24# 10-thd. New Seamless casing was set in this well at 3852' and cemented by the Halliburton Method with 100 sacks cement.

Casing and fittings were tested with 1800# pump pressure and allowed to stand undisturbed for thirty minutes. Cement plug was then drilled out of casing and the same test again applied and allowed to stand undisturbed for thirty minutes. No drop in pressure resulted and drilling was resumed.
