8-5/8" 28# 8-thd. New Electric Weld casing was cemented in this well at 2534' and cemented by the Halliburton method with 225 sacks of cement.

Casing and fittings will be tested with 1200# pump pressure and allowed to stand undisturbed for thirty minutes. Cement plug will then be drilled out of casing and the same test again applied and allowed to stand undisturbed for thirty minutes.
