Loaded hole with lease crude oil and sand-oiled 6-5/8" OD casing perforations from 2833' to 2843', 2890' to 2912', 2984' to 2994' 3430' to 3505' and 3520' to 3620' with 10,000 gallons of Famariss 24 gravity oil and 10,000 lbs. sand, pumped down tubing and casing. Rigged up and swabbed well in, and well started flowing. Flowed at the rate of 2,811,000 cubic feet of gas per day.
