DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

8-5/8" 28# New Electric welded casing was set in this well at 2370' and cemented by the Halliburton Method with 800 sacks of cement. 500sacks through the casing and 300 sacks through the bardenhead.

Casing and fittings were tested with 1200# pump pressure and llowed to stand undisturbed for thirty minutes. No drop in pressu e resulted. Cement plug was then drilled out of casing and the same test of 1200# again applied and allowed to stand undisturbed for thirty minutes. No drop in pressure again resulted so drilling was then resumed.
