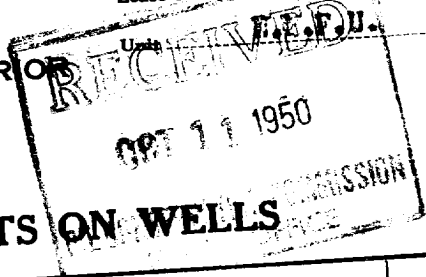

On 5-10-50 acidized the interval 3850' to 3883' with 1,000 gallons acid. After acidization produced 8 barrels oil and 15 barrels water in 24 hours through 16/64" choke with a gas-oil ratio of 112,000 cubic feet per barrel.
