It is proposed to squeeze off the Queen perforations in this well, to prepare it for inclusion in the expansion area to the Eunice Monument South Unit, by the following procedure:

1. RIH with bit and casing scraper to TD at 3859'.
2. Set RBP at 3655' and squeeze Queen perforations (3356'-3630') with 250 sxs cement.
3. Drill out cement and retainer.
4. Pressure test casing to 500 psi for 30 minutes.
5. RIH with producing equipment and resume production pending assumption of operatorship by Chevron.
