Max pressure 150#. Cement circulated. WOC 12 hrs. tested 9-5/8" OD Csg. w/1000# before and after drilling cement - OK. Drilled plug & cement from 278' to 307' & washed to bottom 312'. Started drilling formation & 8-3/4" hole @ 7: P.M., 5-11-54.
