Re: Application to Dually complete
Amerada L. W. White No. 1,
Sunice-Monument Pool, Lea
County, New Mexico.

Gentlemen:

By copy of this letter Amerada Petroleum Corporation wishes to state
the following:

(A) That Amerada Petroleum Corporation L. W. White Well No. 1 located
660 ft from the south line and 660 ft from the east line of Section
34, T-20-S, R-36-E, Lea County, New Mexico, was completed July
10, 1954, at a drilled out depth of 3930 ft. The attached Exhibit
A shows the location of this well on the Amerada White Lease
together with the location of all offset wells.

(B) That the subject well has 7" casing set at 3935 ft and connected
with 800 sacks of cement. The well is an oil well producing
from the perforated interval of 3774 ft to 3812 ft; 3824 ft to
3860 ft and 3874 ft to 3914 ft in the Lower Seven Rivers formation,
Sunice-Monument Pool.

(C) That the applicant proposes to dually complete the well in the
following manner:

(1) Perforate the 7" casing in the interval of 3588 ft to 3632
ft and 3644 ft to 3668 ft in the middle Seven Rivers formation.
(2) Set a production type packer below these perforations at
3743 ft to separate the two pay zones.
(3) Produce the Lower Seven Rivers oil through the tubing and
the middle Seven Rivers gas through the tubing-casing
annulus.

(D) That the granting of this application for permission to produce
the well as a dual completion is in the interest of conservation
and the protection of correlative rights.
