FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production, it is proposed to plug back and fracture treat as follows:

1. Pull tubing, rods and pump. Run steel line measurement, if warranted clean out with sand pump. Run Gamma Ray Neutron survey.
2. Plug back with Hydramite to point determined by survey. Run 2-7/8" tubing with formation packer. Treat formation beneath packer with 8000 gallons refined oil with 1# sand per gallon. Block fractured zone with crushed mothballs in lease oil. Treat formation with 8000 gallons refined oil with 1# sand per gallon.
3. Pull tubing and packer. Run 2-3/8" tubing and return well to production.
