" " 2000' of 7 5/8" Casing.

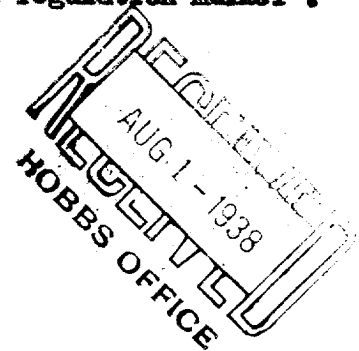
" " 3800' of 5 1/2" Casing.
