Ran 2-3/8" 4.7# J-55 IPC-TK-90 tubing with Guiberson tension type packer. Set tubing at 3699', packer at 3665'. CI disc in bottom of tubing.
Well will be shut in until construction of Central Waterflood Plant is completed.
