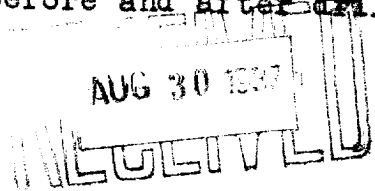

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

5 1/2" OD casing was set at 3833' and cemented with 425 sacks on August 22, 1937.

After cement had been allowed to set 72 hours casing was tested with 1200# pressure for 30 minutes both before and after drilling plug. Casing tested OK.
