FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production it is proposed to plug back and fracture treat as follows:

1. Pull tubing, packer and safety joint.
2. Run 2-3/8" tubing with 4-3/4" bit and drill out cavings to 4010'. Run caliper survey.
3. Plug back with Hydramite to 3990'.
4. Run 2-7/8" tubing and packer set at approximately 3875'.
5. Treat formation below packer with 10,000 gallons gelled lease oil with 1# sand per gallon.
6. Pull 2-7/8" tubing and packer. Run 2-3/8" tubing and return well to production.
