FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production it is proposed to plug back and fracture treat as follows:

1. Pull 2-3/8" tubing.
2. Run steel line measurement. Clean out with sand pump if necessary.
3. Plug back with Hydramite to 3975'.
4. Run 2-7/8" tubing with Lynes self anchoring packer at approximately 3875'.
5. Treat formation below packer with 10,000 gallons gelled lease oil with 1# sand per gallon.
6. Pull 2-7/8" tubing and packer, rerun 2-3/8" tubing and return well to production.
