- 1) MIRUPU. TOH with rods and pump. Install BOP. Tag last known PBTD of 3935' with tubing. TOH. CO fill to PBTD 3922', if necessary.
- 2) With 3 3/8" Schlumberger Ultra-Jet gun, shoot the open hole with 2 spf at 3876', 78, 80, 84, 86, 88, 90, 92, 94, 3912', 14, 16, 18, (13 intervals, 26 holes). Run CCL for correlation.
- 3) TIH with 7" treating packer on 2 7/8" workstring. Set packer at $\pm$ 3376'. Pressure test backside to 500#. If leaks occur, locate with packer, then isolate leaks with cement retainer and CIBP and squeeze with $\pm$ 100 sxs. Class "H" with 2% CaCl₂. WOC. Drill out and retest. Reset packer at $\pm$ 3776'.
- 4) Acidize the Grayburg open hole with 3500 gallons 15% NEFE acid and 1 drum Checker-Sol mutual solvent. Pump at 4 BPM at 2500#. Flush to packer. Release packer and TOH.
- 5) With 3 3/8" Ultra-Jet gun, shoot 7" casing with 2 spf at 3810', 12, 16, 18, 20, 22, 28, 30, 32, 34, 36, 38, 40, 42, 44, 48, 54, 56, 60, 62, (20 intervals, 40 holes). Use previously run CCL for correlation in casing.
- 6) TIH with 7" RBP and treating packer. Set RBP at 3865' and packer at $\pm$ 3710'. Load backside to 500#.
- 7) Acidize the Grayburg perfs at 3810'-62' with 4500 gallons 15% NEFE acid. Pump at 5 BPM, 4000#, dropping 60 ball sealers. Flush to top perf. SI 1 hour. (OVER)

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

- 8) Swab perfs at 3810 62' and test oil and water cut.
- 9) Release packer and RBP, then TOH.
- 10) TIH with production equipment. ND BOP. RDP. POB and test.
- 11) After all load water is recovered, perform a barium squeeze utilizing 3 drums Visco 3920 and 300 bbls. brine.
