FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production it is proposed to plug back and fracture treat as follows:

1. Pull tubing.
2. Run steel line measurement. Clean out with sand pump if necessary.
3. Plug back to 3958' with Hydromite. Run short arm caliper.
4. Run 2-7/8" tubing with self anchoring packer. Treat formation with 12,000 gallons gelled lease oil with 1/4 sand per gallon.
5. Pull 2-7/8" tubing and packer, run 2-3/8" tubing and return well to production.
