Plugged back and acid treated as follows:

1. Ran SLM. Dumped 64 gallons hydwrite in 5 dumps. Pressured each dump with 400# water pressure. Plugged back from 3930' to 3903'.
2. Set 2-3/8" tbg at 3891' with heckwall packer at 3658'. Swabbed and tested.
3. Treated with 500 gals 15% NE acid. IR 4 bpm. TP 1000#.
4. Unseated packer, ran rods and pump.
