DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

12 1/2" 40# 8-thd. New lapweld casing was set in this well at 185' and cemented by the Halliburton Method with 180 sacks.

Cement was drilled out of the casing and the hole was bailed to bottom and then allowed to stand undisturbed for one hour. The bailer was then run to bottom and the hole was dry so the drilling was then resumed.
